Dear Ohio Elections Commission:

My name Matt Ford and I represent Friends of Nordonia Hills School PAC. We are registered with the Summit County Board of Elections. It has come to our attention that a group of people, led **by Michael Smith 96 Heights Avenue, Northfield Village, Ohio 44067 email – TellJoeNo@outlook.com**, have gotten together to raise money for a ballot issue and have failed to form a Ballot Issue Committee and file with the Summit County Board of Elections. A ballot issue committee, sometimes called a ballot issue PAC, is a political action committee that is organized to support or oppose a proposed or certified ballot issue or question.

- By definition a PAC is: A combination of two or more persons, the primary or major purpose of which is to support or oppose any candidate, political party, or issue, or to influence the result of any election through express advocacy. R.C 3517.01(C)(8)
- On September 8, 2022, and September 16, 2022, Michael Smith formed a Ballot Issues PAC when he posted on the Facebook page "The Real Nordonia": Fig (1a) and fig (2)
 - We need funds for VOTE NO signs. Please contribute via cashapp \$therealnordonia. I will personally contribute what I can to complete the process, and I will pass out the signs. If possible, we'd like to also get 2 banners, 1 for 82/8, and the other for as near to the board offices as possible. Fig (2)

By using the pronouns, we, Michael is designating a group of two or more, furthermore, Michael is also stating that that he will not be funding the entire process by stating that "personally contribute what I can to complete the process". This will be funded by two or more people.

Michael Smith violated R.C. 3517.018, 3517.10(D) By receiving contributions before filing a
Designation of Treasurer.

- Before receiving contributions or making expenditures, a ballot issue committee must file Form 30-D, Designation of Treasurer. This form registers the committee and includes basic information such as the name and address of the ballot issue committee, the name of the treasurer and their address, and any deputy treasurers.
- Michael Smith violated R.C. 3517.10 by accepting contributions via a cashapp account that
 was not solely designated for the PAC. \$therealnordonia cashapp account had been used
 previously on April 11, 2022, fig (1b) and July 13, 2022, fig (3) to solicit donations not related
 to a ballot issue.
 - A PAC must establish a bank account that is separate from all other accounts. All
 monetary contributions received must be deposited into this account. Contributions
 may not be placed in any other personal or business account. PACs must disclose all
 contributions received and expenses paid from this account.
- Michael Smith Violated R.C. 3517.105(A) by not disclosing a disclaimer on yard signs against Issue 5 fig (4). Michael Smith does not qualify for a Limited PAC or PCE R.C 3517.105(A) because over \$100 was spent on signs. Fig (5)




Current bond voter situation:




